



Community Resources Options

The Federal and state Government Implements programs that aim to help individuals attain Health care. For individuals of limited resources Medicaid offers plans that pay fully for qualified care, or partially for health care.

Where to apply: Individuals local Department of Family and Children Services (DFCS) individuals can also apply in person, mail, fax, and telephone. [How to Apply? | Georgia Medicaid](#)

To qualify individuals must meet State and Federal income Guidelines.

(SSI) Supplemental Security Income

The Supplemental Income program provides a benefit for Individuals who are disabled, blind or age 65 or older with limited resources and income. If you receive (SSI) you qualify for Medicaid.

To qualify individuals must meet State and Federal income Guidelines and provided required documentation on area of disability. Is a U.S. Citizen or national or a non-citizen in one of certain classifications granted by the Department of Homeland Security (DHS).

Early and Periodic Screening and Treatment (EPSDT)

¹States are required to provide comprehensive services and furnish all Medicaid appropriated medically necessary services needed to prevent and correct health conditions based on Federal Guidelines.

Medicaid eligible children receive periodic full and Health preventive care such as early screening for developmental conditions and disorders that may affect children to age 21, This program also covers medical and wellness exams, immunizations, mental, behavioral health, dental, hearing, vision, and specialty services.

Home and Community Based Services (HCBS)

²Section 1915 of the social Security Act authorizes the Secretary of Health and Human Services to waive certain Medicaid rules. This allows for states to pay for Home and Community based services, instead of services in institutions allowing individuals with disabilities to remain in home and community as decided in the ³ 1999 Supreme Court precedent *Olmstead v. L.C.*, affirming the right for individuals with disabilities to receive services in the most integrated setting appropriated to their needs.

(HCBS) Waivers

Requires individual to qualify for Medicaid, states allocated funds for program with a limited number of individuals served. There is a waiting list for program. Individuals with disabilities can advocated for more funding during the legislative session's discussion of the proposed disclosures of allocated funding for programs in state. constituents can also contact Local representatives and senators.

Program serves elderly and disable functionally impaired that meet a nursing home level of care. [HCBS | Georgia Department of Community Health](#)

⁴Independent Care Waiver (ICWP) Serves adults who are physically disable and or have traumatic brain injury (TBI) and meet a hospital or nursing home level care.

Option Waiver Program (NOW) and Comprehensive Supports Waiver Program (Comp) serves individuals with intellectual or developmental disabilities who meet and immediate care facility level of care.

Georgia Pediatric Program (GAPP) Serves medically fragile children or children who required regular nursing care.

Community Care Services Program (CCPS)

Program provides home and community care for individuals with disabilities, elderly individuals and/or functionally impaired. Program helps individuals return to community or regain in their own home.

Money follows the Person (MFP) Demonstration Program

The program helps people that have been living in an inpatient facility (nursing home, or psychiatric residential treatment facility and immediate care facility for individuals with intellectual disabilities for a least sixty (60) consecutive days to qualify for transition services from facility to home community.

TEFRA/ Katie Beckett Program

Serves Medicaid eligible, who 18 years old or younger and meets the Federal criteria for disability and is financially Ineligible for (SSI) benefits and requires a level of care provided in a hospital or skilled nursing facility for individuals with intellectual disabilities and cannot be appropriated be care at home.
